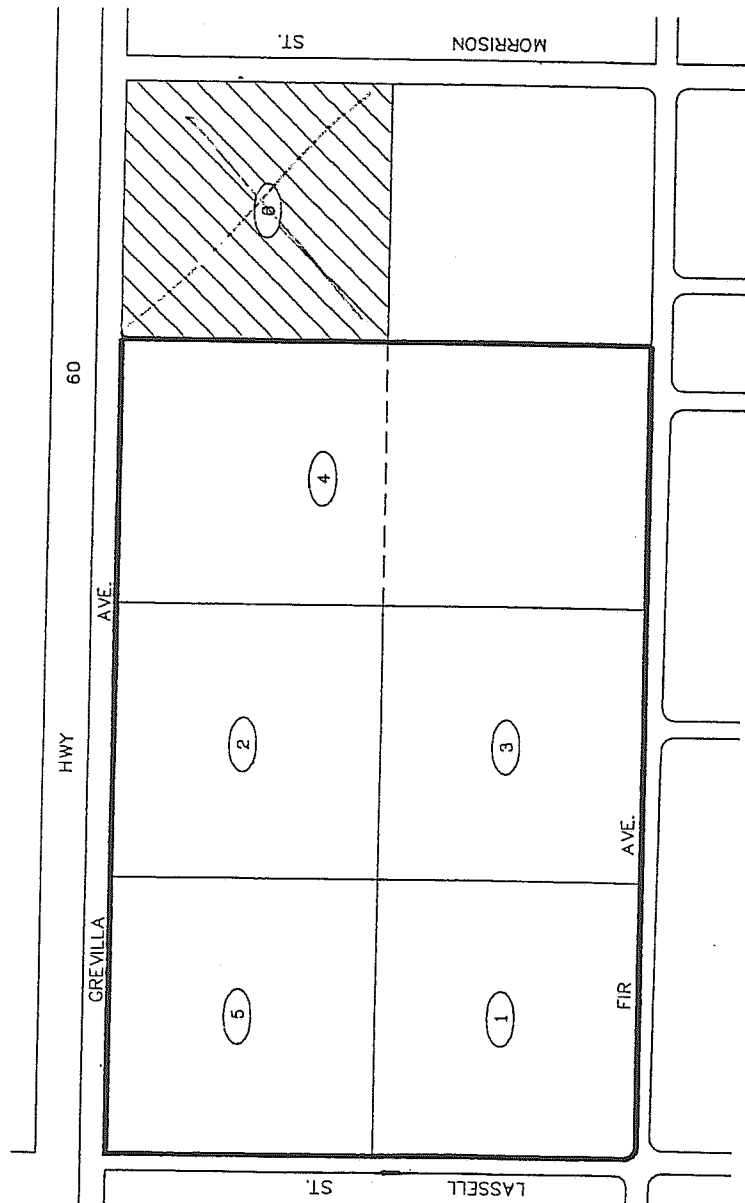


PROPOSED BOUNDARY MAP OF COMMUNITY FACILITIES DISTRICT NO. 2003-1
